
Affected are the safety caps of the CA- and CM-series. Please find an overview over all affected material numbers and article descriptions in the table at the end of this document.

Details of Change(s):

The product change implies the modification of the fixing string used to securely fasten the dust caps in an unmounted condition. In the course of the product change the so far used perlon string will be replaced by an elastic plastic band being improved regarding tensile stress, handling and appearance.

The highly flexible fixing strap is designed in a way it can be used with both field-attachable and receptacle connectors. If the safety cap is used in combination with a field-attachable connector, the variable loop comes into action with which the cap is attached to the connector housing.

If the cap shall in contrary be fastened with the aid of a screw, the borehole on the strap can be used. In that case the variable loop is not needed. The marking on the band indicatives where it can be cut off.

Due to the combination of borehole and size-adjustable loop it is no longer necessary to distinguish between a version for field-attachable connectors and another version for receptacles. Much rather can the new safety cap be used flexibly for both connector types.

As a result the former perion variant with fixed string will be discontinued when the product modification comes into action as mentioned in the end-of-life-notification.
