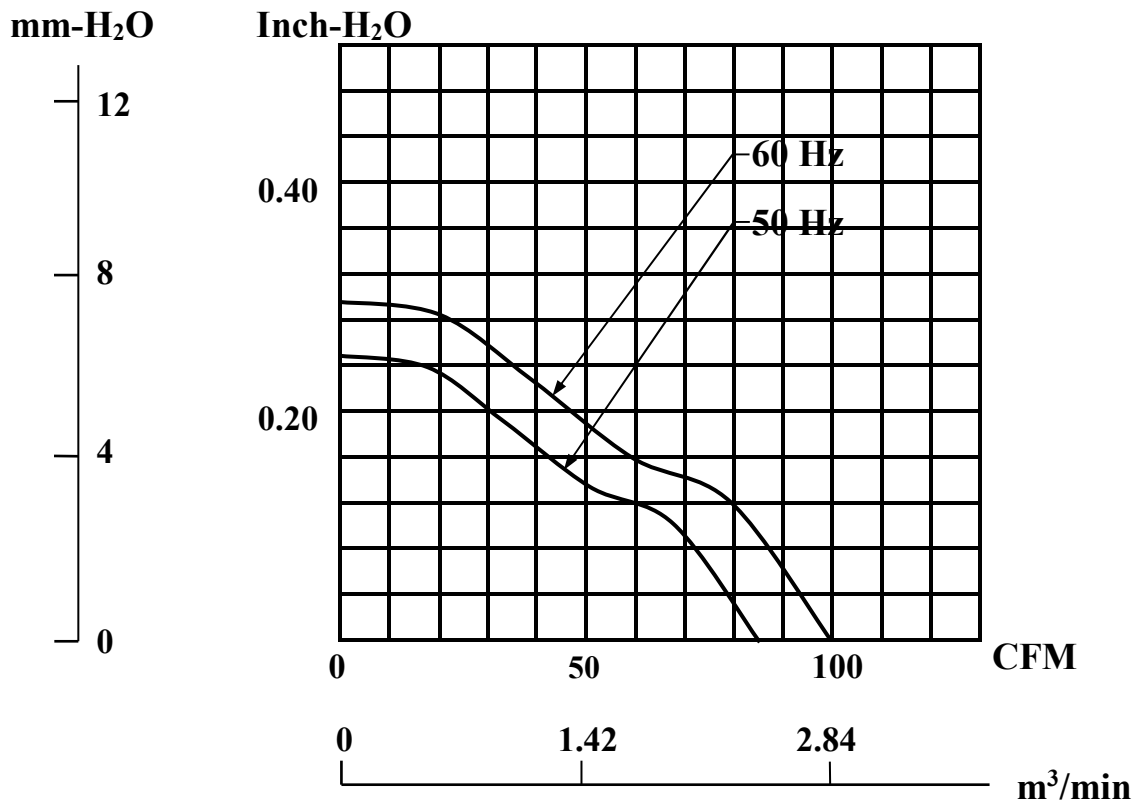

PRESSURE**



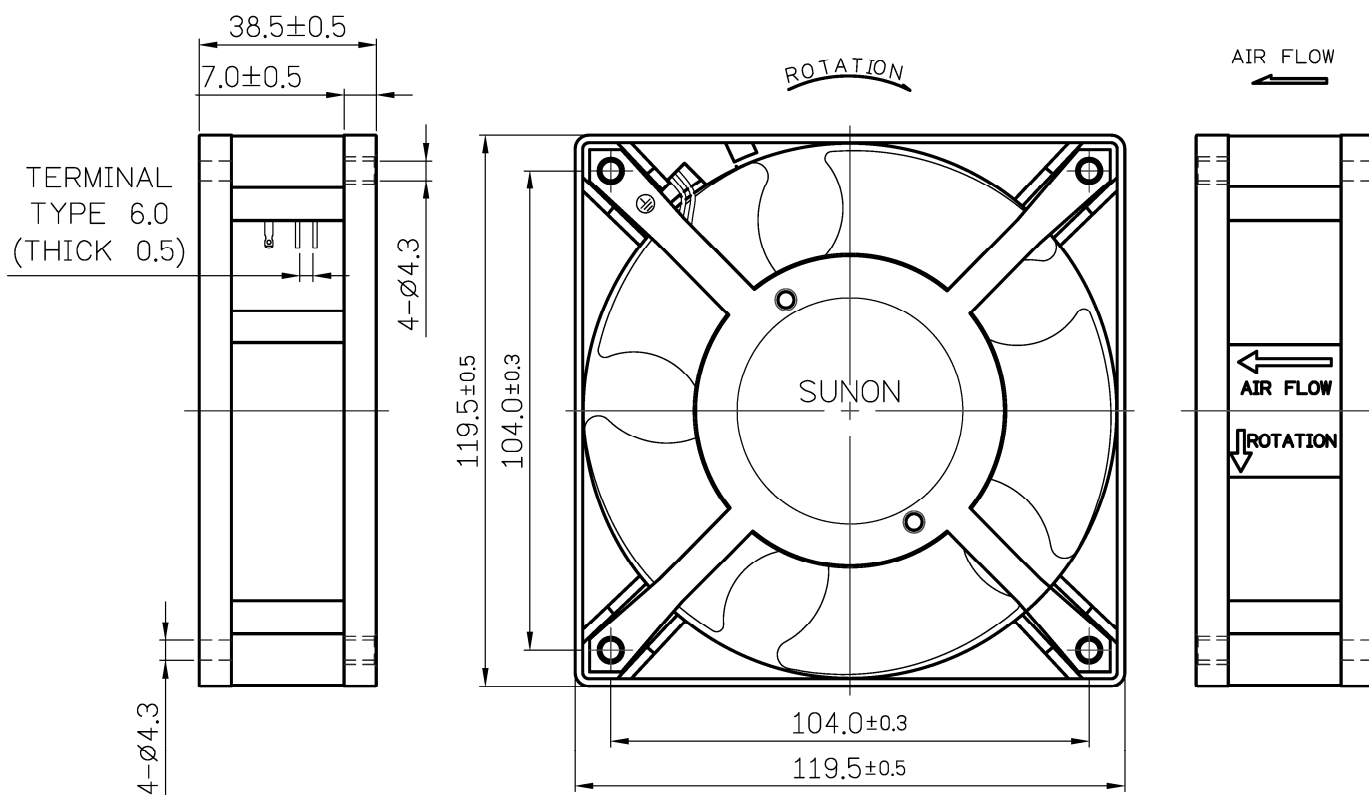
