Reflow Soldering Profile For Lead-free SMT Process.



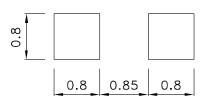
- NOTES:

  2.Don't cause stress to the epoxy resin while it is exposed to high temperature.

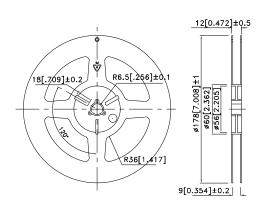

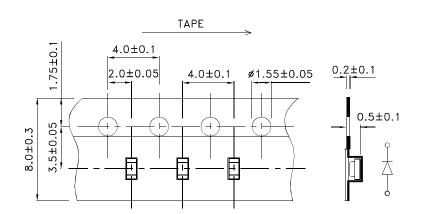
### **Recommended Soldering Pattern** (Units: mm; Tolerance: ± 0.1)
