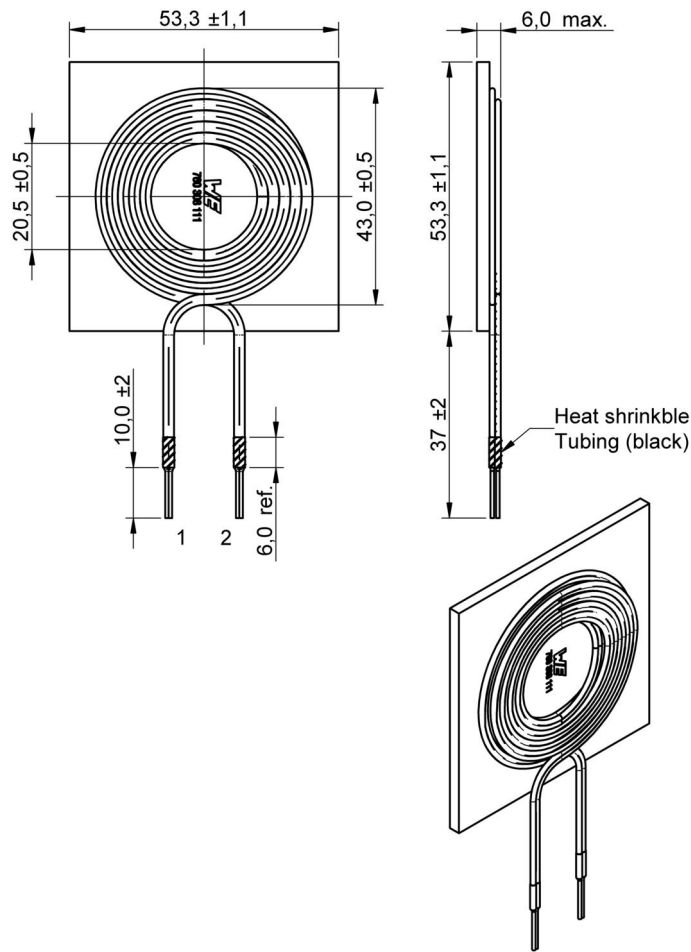
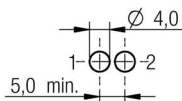

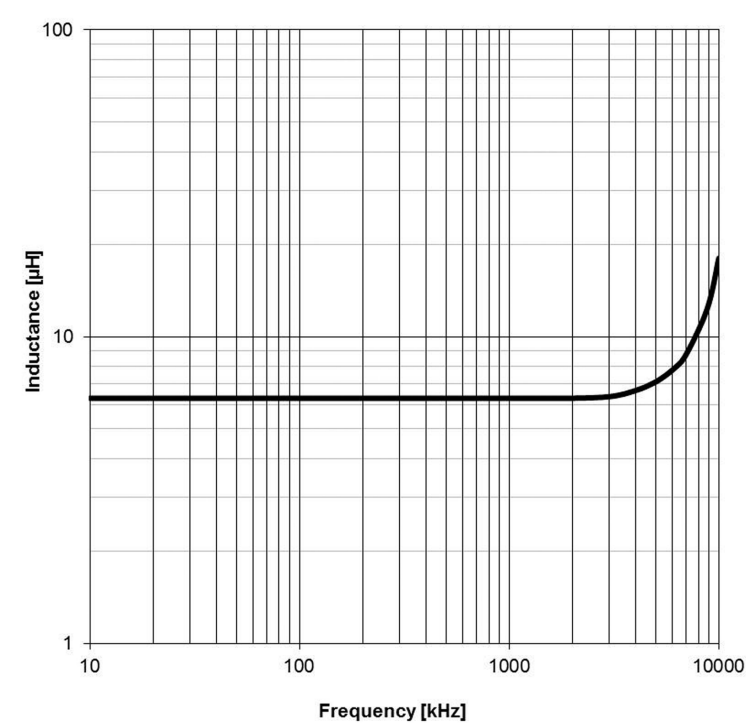





F1 Typical Inductance vs. Current Characteristics:



F2 Typical Inductance vs. Frequency Characteristics:

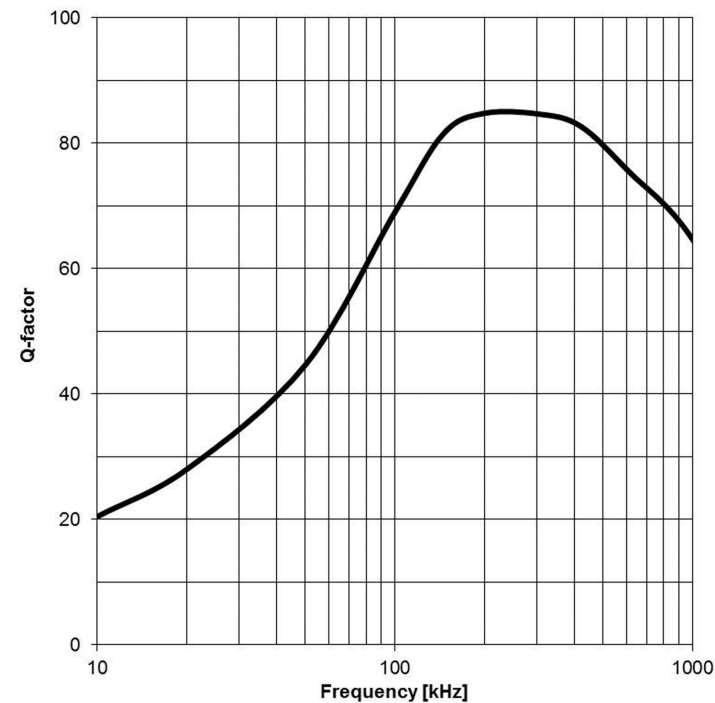

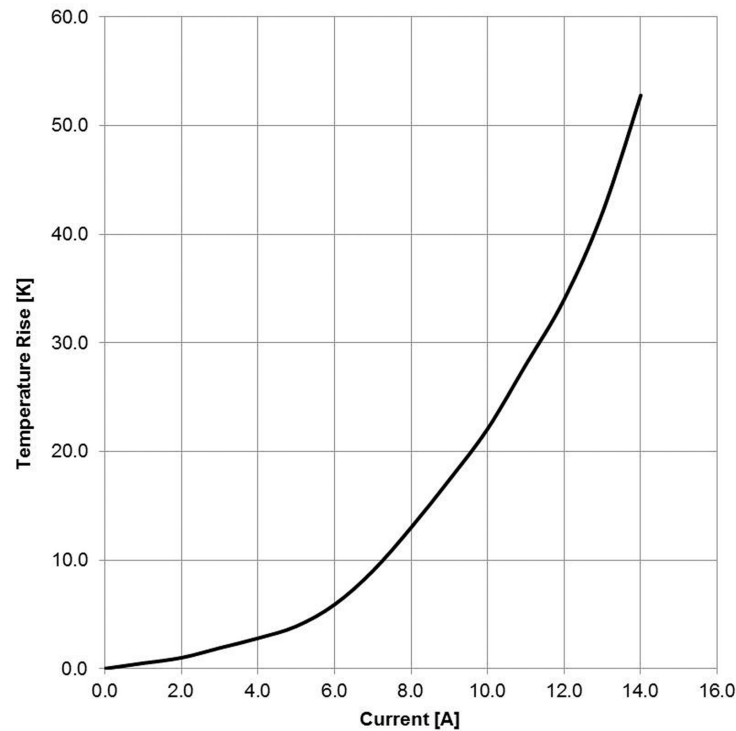





F3 Typical Q-factor vs. Frequency Characteristics:

General:

If the product is potted in customer applications, the potting material might shrink during and after hardening. 
