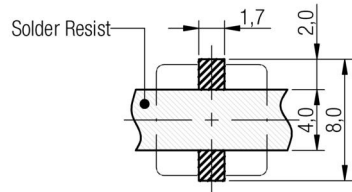

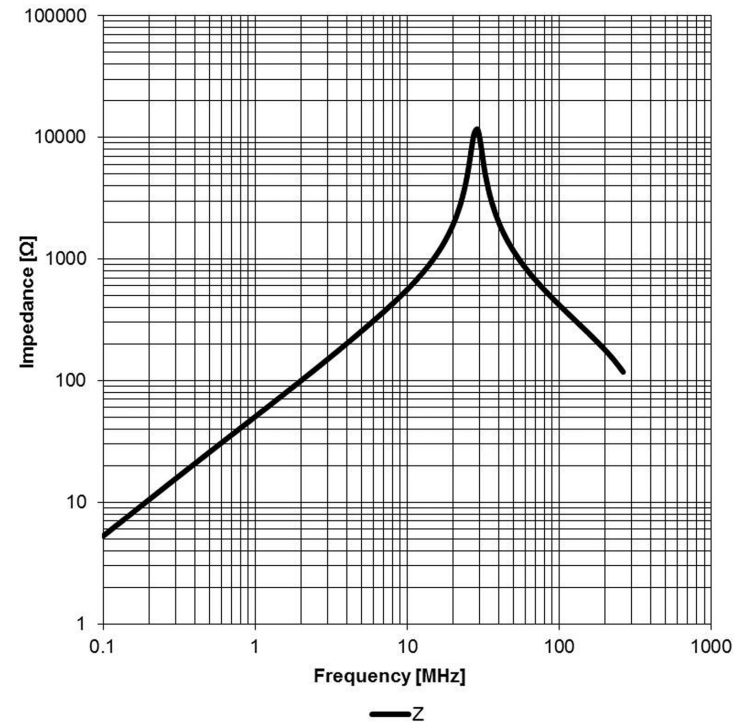



### Product specific:
