


F1 Typical Inductance vs. Frequency Characteristics:

- Strong forces might have the effect to damage the coplanarity of the electrical connection (pins), will restrain the soldering and void the warranty.
- •Please notice that the recommended thickness of the soldering paste is 120 µm.
