Ambient Temperature T_A (°C) LUMINOUS INTENSITY Vs. AMBIENT TEMPERATURE



Reflow Soldering Profile For Lead-free SMT Process.





 2.Don't cause stress to the epoxy resin while it is exposed to high temperature.




Recommended Soldering Pattern (Units: mm; Tolerance: ± 0.1)

Reel Dimension








