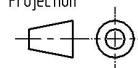

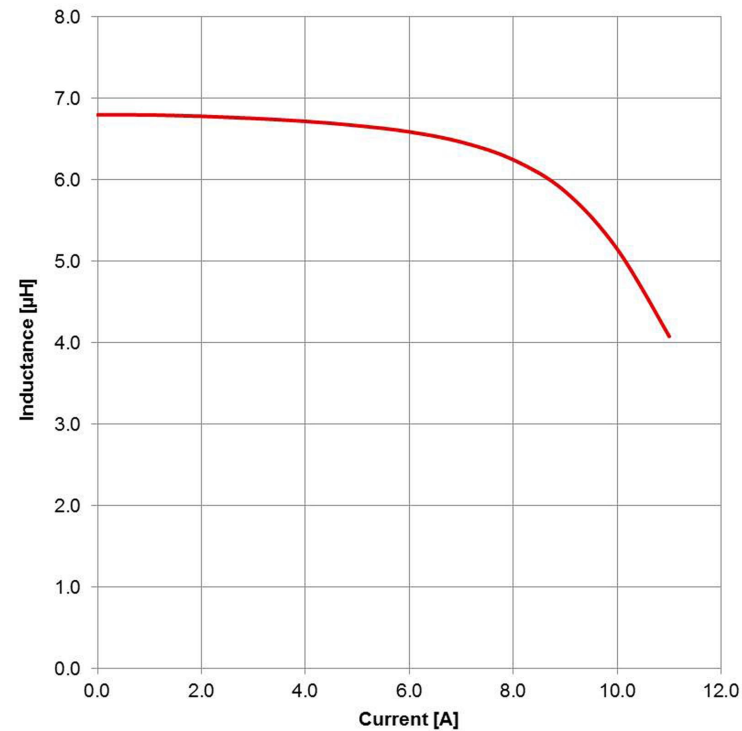

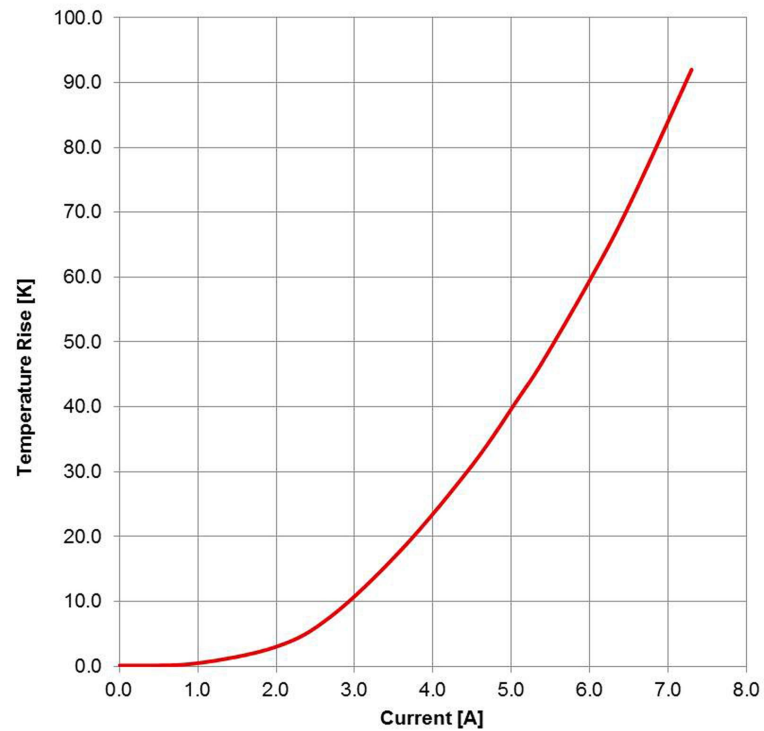

F2 Typical Temperature Rise vs. Current Characteristics:

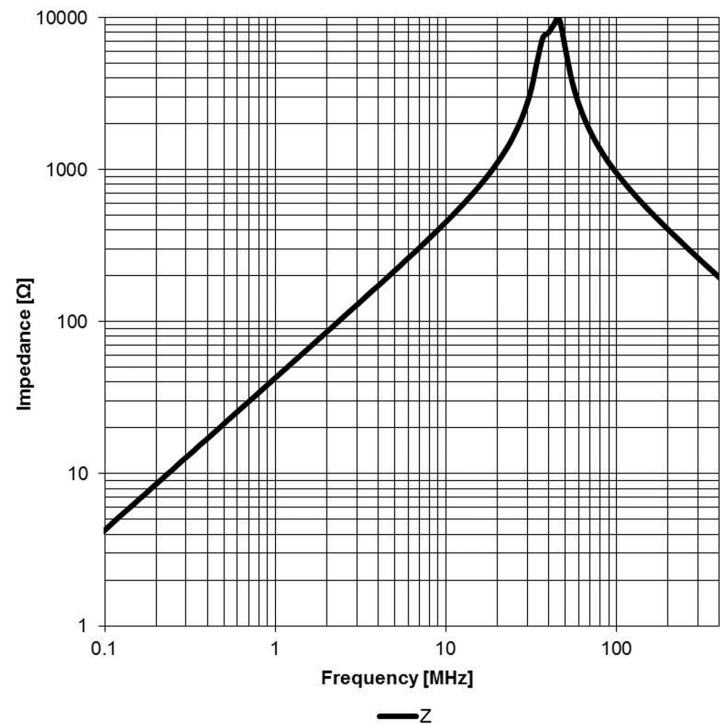



### Product specific:


