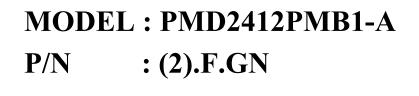

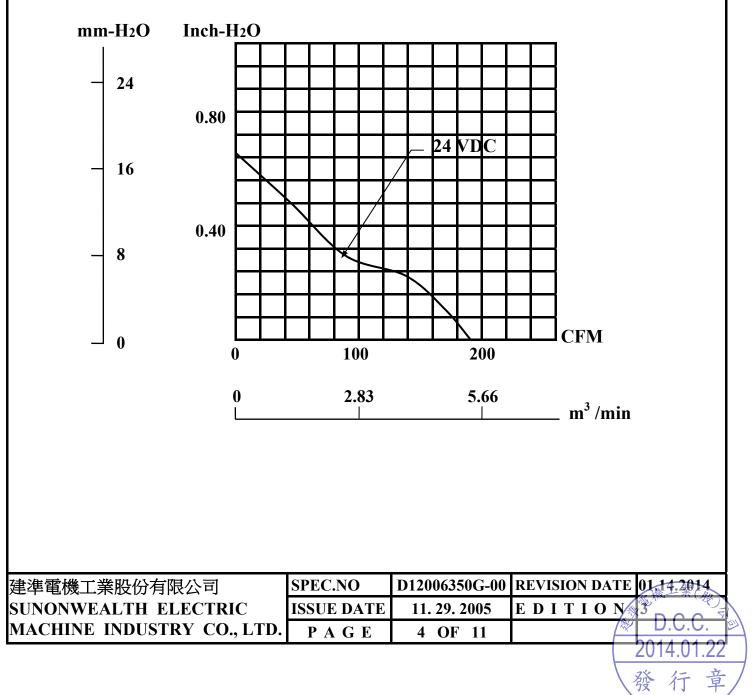

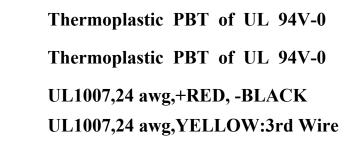
PERFORMANCE CURVES
