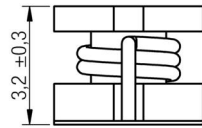

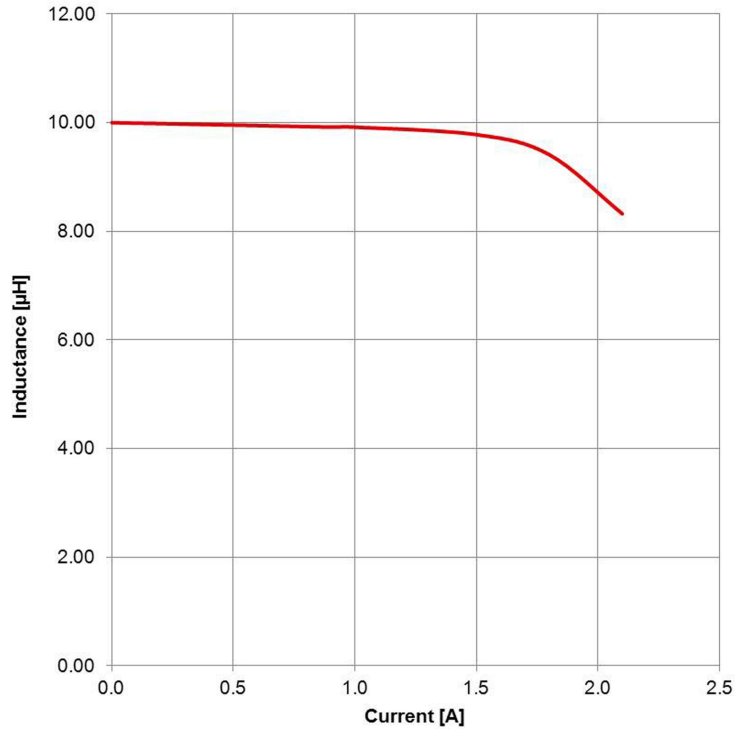

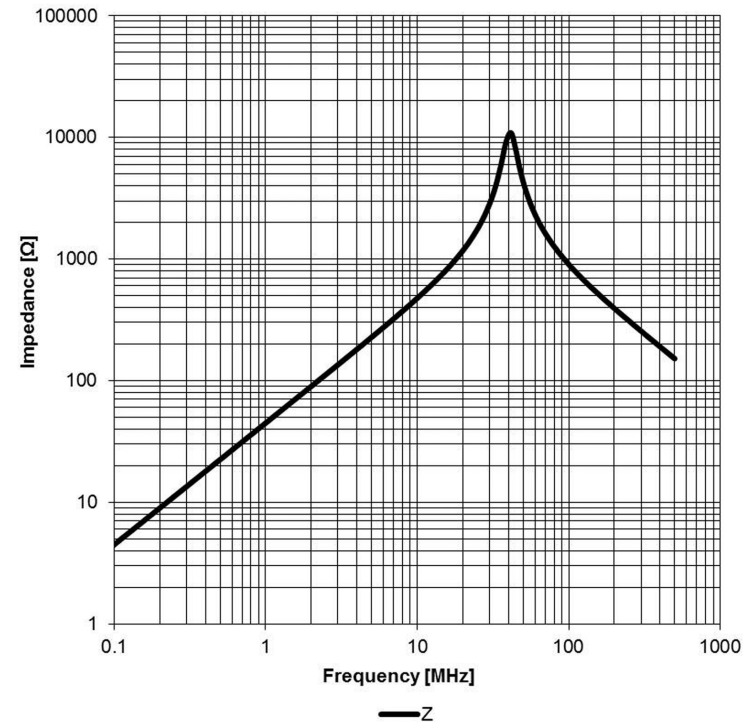



### Product specific:
