# F1 Typical Inductance vs. Current Characteristics:







- •All products shall be used before the end of the period of 12 months based on the product date code, if not a 100% solderability can't be ensured
- Violation of the technical product specifications such as exceeding the nominal rated current will void the warranty.
- •Solvents may influence the product marking.
